Mr. Munson managed Robey Theatre for a time and had a print shop in the basement of the building where he printed show bills, newspaper ads and booklets, one in particular titled, "Munson's Money-Making Manuel. Mrs. Munson was a Roane County school teacher. Mr. Taylor reported that he did odd jobs for the Munson's over the years until her death in 1981.
